- Introduction: The Significance of Words
 - Words have power to shape events and change lives (e.g., vows, verdicts, resignations).
 - Visionary words, like a mission statement, guide and inspire collective direction.

 - Nehemiah's Time:
 - The Israelites, returning from exile, rediscover their identity through the reading of the Law.
 - Ezra's reading reminds them they are God's covenant people and inspires commitment to God's commands.
 - Jesus' Nazareth Manifesto:
 - Jesus sets out His mission by quoting Isaiah, proclaiming good news, freedom, healing, and justice.
 - His declaration, "Today, this scripture is fulfilled in your hearing," emphasises the present reality of His vision.

- Minster 28 Vision Strategy:
 - Aims to guide Beverley Minster in becoming "more like Christ."
 - Emphasises concern for the marginalized and sharing God's love beyond the church.
- Vision provides clarity, direction, and purpose, as it did for the Israelites and in Jesus' ministry.
- Call to Action
 - Reflect on how you can embody Christ's mission in your context.
 - Engage with Minster 28 through prayer, discussion, and feedback.
 - Seek to align personal and communal life with God's ongoing revelation and grace.
- Conclusion: The Need for Vision
 - Vision helps us know who we are, where we're going, and how to respond to God's calling.
 - By focusing on Jesus and becoming more like Him, we naturally bring good news and transformation to the world.
